Consultation with COPs and Clinical Council on the future of health

Back-up ventilator solutions

NSW Health, led by Health Infrastructure (HI), has been working with universities and industry partners to support the NSW Government's rapid progress in the manufacture of back-up ventilator solutions in NSW, should they be required in the response to the COVID-19 pandemic.

The ventilator solutions are part of a multi-pronged approach to ensure NSW has enough ventilators available to care for those patients with COVID-19 who need this level of care.

PPE Update

Critical PPE Stock on Hand (SHEOC update)

- NSW Health continues to improve the controls associated with ordering to manage current and incoming PPE supplies in line with requirements across the LHDs. The statewide position of surgical masks has improved over the last week due to deliveries arriving at the warehouse. Key focus is on improving the availability of the XL/XXL sizes of level 4 surgical gowns.
- In conjunction with the close management of ordering practices, LHD "cycle counts" of local stock on hand continue weekly to better ascertain stocks held across the LHDs / health facilities and data quality has significantly improved. Cycle 11 was completed on 3 June. Cycle Count 12 is underway.
- The most recent cycle counts have been refined to obtain better line of sight on PPE usage rates and ensure usage is in line with PPE guidelines developed by the CEC. LHDs have access to a statewide dashboard of stock levels across critical items.
- Work continues to ensure ordered stock is confirmed and committed to by suppliers, given the current evolving environment around the global supply chain. This can change due to a range of variables and factors outside of our control. However, NSW Health is working around the clock to build the confidence of the delivery of incoming supplies.
- It is important to note numbers can move day-to-day based on dispatched and incoming stock.
- In addition to the current stock LHDs have on hand, Table 1 below shows additional existing NSW Health warehouse stock.
- There is additional PPE held at the Whole of Government warehouses commissioned as part of the COVID response, of which a large quantity of this stock is allocated for NSW Health use and supplements the Onelink stock outlined in Table 1.

Weekly medication updates

The CEC is collaborating with HealthShare to produce a weekly update of medications that are being monitored closely due to potential increased therapeutic need or known/anticipated supply chain concerns. These updates can be found on the CEC website.

COVID-19 weekly surveillance in NSW

Summary for the week ending 30 May

- The number of new COVID-19 cases remain low in NSW and mainly in overseas travelers.
- Testing rates were higher this week across most local health districts and increased significantly this week in school aged children.
- The small proportion of COVID-19 tests in the week that were positive indicates that the spread of infection within the community continues to be limited.
- Two of the newly notified cases were students who attended school during their infectious period. The cases were promptly isolated and all close contacts at the two schools have been quarantined. All close contacts of the students are being monitored in quarantine.
- Community restrictions and physical distancing measures in place to control the spread of COVID-19 have had a positive impact on the transmission of other respiratory illnesses:

- $\circ~$ The number of people diagnosed with influenza has been declining since early February.
- Presentations for pneumonia to NSW emergency departments have decreased below the usual range for this time of year.
- There is a decrease in reported typical flu-like symptoms for this time of year.
- Continued high rates of testing are necessary to detect and reduce the spread of COVID-19 in the community.
- NSW Health urges people of all ages, including children, to undergo COVID-19 testing and isolate themselves as soon as mild symptoms of respiratory infection or fever appear.

In Focus – COVID-19 in Aboriginal people: 1 January to 30 May 2020

A review of COVID-19 cases in Aboriginal people up to 30 May found:

- Thirty-one Aboriginal people have been diagnosed with COVID-19. This represents a small proportion of all COVID-19 cases (1%).
- The population rate of COVID-19 is lower for Aboriginal people (11 confirmed cases for every 100,000) in NSW than the rest of the NSW population (39 confirmed cases for every 100,000 population).
- Of the 31 cases, half most likely acquired their infection overseas and the remaining acquired their infection locally in NSW. Around 75% of all cases who acquired their infection locally are linked to another confirmed case.
- Most symptoms reported were mild, and at least 93% of cases have already recovered.
- Testing rates have generally been increasing for Aboriginal people. Up to 23 May, there were 13,976 COVID-19 tests conducted for Aboriginal people in NSW. Most tests were done by public laboratories.
- Testing rates were similar for Aboriginal and non-Aboriginal people under 60 years old. In older individuals, testing rates were higher in Aboriginal people than in non-Aboriginal people.
- Aboriginal people living in metropolitan local health districts tend to have higher testing rates than Aboriginal people in regional areas.
